# **Meeting notes**

#### **WASH AI**

- Update: Skat has contracted Olivier to develop a chatbot in the WhatsApp Channel created for the Latin American Community to digest and disseminate the knowledge from RWSN and SuSanA users write questions and the chat bot generate answers based on the RWSN and SuSanA website content. The funding comes from the IDB. The plan is to have it ready for testing in November. The bot will be in Spanish for the time being.
- Status of AI tool: feature is being developed by Olivier, they are going to use RWNS and SuSanA for the content
- Data protection and European laws everything seems to be in order
- Ideally it would be using everything in the SuSanA website (incl. SuSanA library and SuSanA forum)
- 5 to 10 people will be testing the WhatsApp feature in November (Dorothee, colleague and Carla would like to test the AI tool)
- If this is successful, we could think about replicating it to other regions and adding the chatbot feature to the SuSanA website.
- The GSC is happy to support this initiative as we think this could be a good opportunity to use the resources from the SuSanA website and other knowledge.
- Alex will let Sean know that Dorothee, colleague and Carla are interested in testing the tool

# RWSN for the backstopping of the Swiss Network RESEau

- Update: There is currently a tender for a proposal to do backstopping of the water network RESEau- this means supporting the management of this network on various levels.
- RWSN would like to have a joint proposal with SuSanA
- SKAT would lead the proposal with some input from the secretariat the money would go through SKAT foundation, and we would have in kind contribution of SuSanA (still to be defined)
- Alex will ask Sean to organize a brainstorming call on the potential bid and talk about the role of SuSanA Dorothee, Arwa (has experience working with RESau), Carla would be available to join the meeting
